Games and Tournaments will be scheduled periodically throughout the Fall. Exact dates are still to be determined at this time. **Games** last approximately 1 HOUR and typically be a Club vs. Club match, meaning that 1-2 team(s) from each Club will directly verse each other to determine a winner. **Tournaments** also known as double-headers can last up to an ENTIRE DAY, but in some cases may only be a couple hours. Tournaments are also where Clubs earn their "seed" into the Championship season.

CHAMPIONSHIPS

APRIL/MAY 2026

REQUIRES QUALIFICATION

The Championship tournament will be in either the month of April or May 2026 and requires qualification to attend. If the team(s) qualify for Championship play (via Tournament seeding), information will be presented to families as it becomes available.

ELIGIBILITY

Club Stunt is governed by USA Cheer. Membership is required and follows the ages below for team eligibility:

LEVELS - Club Stunt does NOT follow traditional All Star levels. Athletes of all skill sets from beginner to advanced are welcome and encouraged to tryout.

IMPORTANT DATES

EVALUATIONS / TRYOUTS

JAN 29TH 5:00 - 7:00 PM

Athletes will be evaluated for official rostered positions on this date. Teams will be announced on or before February 1st.

UNIFORM FITTINGS

FEB 5TH 7:00 - 8:30 PM

Athletes will be sized for their jerseys on this date. Any athlete not in attendance will be responsible for sizing themselves prior to ordering.

ROUTINE ASSIGNMENTS

FEB 22ND 5:00 - 9:00 PM

Athletes will be given preliminary positions in specific routines on this date. Attendance is mandatory for all participating athletes.

PRACTICES

Each team will be practicing on

Sundays from 6:00-8:00pm and Thursdays from 5:00-7:00pm

Practices begin on February 5th

ABSENCE POLICY - All practices are mandatory. Athletes are allowed to miss two (2) practice without penalty. Any additional absences will incur a \$40 fee per absence.

Games and events will be announced once they become available. We are still waiting on confirmation from USA Cheer or prospective dates.

COST / FEES

TRYOUT FEE

\$100/ATHLETE

Due on upon sign up. Tryout fees cover all clinics and offical tryouts. This fee is non-refundable.

REGISTRATION

\$250/ATHLETE

Due on February 1st. Registration fees cover gym insurance, administrative fees for the team, and Assignment Clinics. This fee is non-refundable.

MEMBERSHIP

\$20/ATHLETE

Paid directly to USA Cheer and requires an athlete protection training and USA Cheer waiver in addition to a one-time **Birthdate Verification for \$5.** Parents will be responsible for initiating athlete membership.

TUITION

\$175/MONTH

CURRENT ALL STAR ATHLETES
60% OFF

Due the 1st of every month and will run February-May 2026.

Current 25-26 All Star athletes will receive a discounted tuition set at 60% of the monthly tuition cost for Club Stunt.

PRACTICE GEAR

\$30/ATHLETE

Due on February 15th. Athletes will receive a practice tank top to will be worn every practice for a cohesive athletic look.

JERSEY

\$150/ATHLETE
APPROXIMATE

Due on March 1st. Athletes will receive an official numbered jersey to be worn for Game-play. Cheer shoes are required and must be ALL BLACK **NFINITY ALPHAS.**

Cheer shoes are not included in the uniform fee and will be sized at fittings.

GAMES

\$35/GAME
TBD / APPROXIMATE

Will be charged with Tuition the month of a game. Game play season runs March-May. Game locations and times will be finalized as they are made available to us from USA Cheer.

CHAMPIONSHIP

\$100-\$125/ATHLETE

Due date pending qualification. The Championship Tournament will be hosted in April/May 2026 and requires qualification. Team attendance is TBD. Athlete travel expenses are the responsibility of each family.

FINANCIAL AGREEMENT

This Financial Agreement ("Agreement") sets forth the financial obligations of athletes and families participating in Nor★Cal Elite's Club Stunt Program.

PAYMENT OF THE REGISTRATION FEE CONSTITUTES ACCEPTANCE OF THIS AGREEMENT AND HANDBOOK IN FULL.

FEES AND PAYMENTS

Athlete and family agree to pay all required fees as outlined in this handbook.

All fees are non-refundable.

ABSENCES

Athletes are permitted two (2) absences per season. Each additional absence will incur a \$35 fee.

GAME / EVENT REQUIREMENT

Attendance at all scheduled games and events is mandatory

Failure to attend may result in a \$300 penalty fee per missed event.

WITHDRAWAL / BOYOUT POLICY

If an athlete withdraws from the team and/or program at any time:

- The remaining balance of all tuition and fees becomes immediately due in full; and
- A \$300 fee per scheduled competition will be assessed; and
- Any additional costs already incurred (uniforms, training, etc.) remain payable.
